CHRISTIAN BEHAGHEL APPOINTED HEAD OF GLOBAL TRANSACTION BANKING

Christian Behaghel is appointed head of Global Transaction Banking and deputy head of Global Transaction & Payment Services starting from May 2, 2013. He will report to Pascal Augé, head of Global Transaction & Payment Services.

In his new role Mr Behaghel's main objective will be to drive Societe Generale GTB's development strategy by supporting its client base of corporate and financial institutions in the management of their global relationships.
