Société Générale's current account holders can now use "i-Transfert" to send money from France to one of the 20 participating countries (see list below).

Customers can make international fund transfers 24 hours a day, 7 days a week, by calling a voice server.

Key features of "i-Transfert":

Transfers available	2 types of international transfers can be made:

	 A cash transfer made available to the recipient at any subsidiary branch on proof of identity.

i-Transfert is a **simple**, **cost-effective**, and **secure** way of sending money abroad:

- Simple: customers call a voice server to make the transfer. The call can be made from France or abroad.
- <u>Cost-effective</u>: a single fee applies to the transaction (including foreign exchange commission):
 - €10¹ for an account-to-account transfer;
 - €20¹ for a transfer of cash for collection in any of the subsidiary's branches.
- <u>Secure</u>: Société Générale and its subsidiaries manage the transfer in full and will process the transaction within the following timeframe:
 - 2 working days for an account-to-account transfer;
 - 3 working days for a transfer of cash for collection in any of the subsidiary's branches.
