

## **Société Générale's "Recruitment days" open at the Stade de France**

To accompany its development in France and internationally, Société Générale will run its 'recruitment days' for young graduates (Bac +2/3) on **29 and 30 September**. This year's event will take place under the name "Société Générale's employment meetings".

The positions on offer cover several of the bank's businesses: customer advisers, multimedia customer relations advisers, back office managers for capital markets and the securities service, and back office managers for international operations.

Launched today via a press and poster campaign, the recruitment program invites candidates to apply online ([www.socgen-recrute.com](http://www.socgen-recrute.com)) or by telephone (01 55 33 43 94). The young graduates selected will then be invited to spend a day at the Stade de France, with recruitment interviews taking place in the corporate boxes, and a behind-the-scenes tour of the stadium. The candidates will receive a response within 48 hours informing them whether the recruitment process will be taken further or not. In 2004, this event led to 100 employment offers for 240 applications.

The event is part of a wider recruitment program which aims to attract at least 8,000 staff members in 2005, both in France and internationally. With over 92,000 employees in nearly 80 countries, the Group has doubled its headcount in 6 years.
